CHAPTER 10-5 ADDRESSING REQUIREMENTS

10-5-1 GENERAL REQUIREMENTS

10-5-1.1 INDIVIDUAL RESIDENCES, APARTMENT BUILDINGS AND PLACES OF BUSINESS

Each and every individual residence, apartment building, and place of business located within the city limits shall have affixed to the front of the structure numbers which represent the street address of same. The numbers shall be of a style approved by the city, at least three (3) inches in height, located approximately five feet above ground level, and in a location adjacent to the front door which is plainly visible from the street.

10-5-1.2 MOBILE HOMES

Each and every mobile home within a mobile home park in the city limits shall have affixed to the exterior wall facing the street numbers which represent the street address of same. The numbers shall be of a style approved by the city, at least three (3) inches in height, located approximately five feet above ground level, and located in the same location on each home.

10-5-1.3 INDIVIDUAL APARTMENTS

Individual apartments regardless whether they are located in apartment buildings or located in buildings with other uses, including separate residential units shall have affixed to the individual apartment, number(s) which represent the individual apartment. In the case of interior entrances, the numbers shall be located on the apartment entry door. Apartments which exit to the street shall follow the numbering requirements in 10-5-1.1 above. The number(s) shall be of a style approved by the city, at least three (3) inches in height, and located approximately five feet above the floor or ground level whichever is applicable.

10-5-2 METHOD FOR DETERMINING CORRECT ADDRESSES

All north/south streets shall be numbered as follows:

Numbers shall range from 0 to 21 in each block with the even numbers being located on the west side of the block and odd numbers being located on the east side of the block. Numbers shall increment by 100 for each successive block with North Street being designated the zero block. Hence addresses in the block immediately south of North Street shall be numbered 000 through 020 on the west side of the block and 001 through 021 on the east side of the block. Addresses in the block immediately south of First Street shall be numbered 100 through 120 on the west side of the street and 101 through 121 on the east side of the street and so on.

All east/west streets shall be numbered as follows:

Numbers shall range from 0 to 21 in each block with the even numbers being located on the south side of the street and odd numbers being located on the north side of the street. Numbers shall increment by 100 for each successive block with Main Street being designated the zero block. Hence numbers in the blocks immediately east or west of Main Street shall be numbered 000 through 020 on the south side of the street and 001 through 021on the north side of the

street. Addresses in the blocks immediately east of Vermont Ave. or West of Pennsylvania Avenue shall be numbered 100 through 120 on the south side of the street and 101 through 121 on the north side of the street.
